

SWEEPSTAKES RULES – CRUISE VACATION GIVEAWAY – BOULDER VALLEY CREDIT UNION

1. To Enter:

The Sweepstakes begins July 11, 2009 at 10AM and ends July 11, 2009 at 3PM ("Sweepstakes Period"). To enter, simply complete a *Cruise Vacation Entry ("Entry Form")* available at Boulder Valley Credit Union's 50th Anniversary Celebration.

2. Eligibility:

Sweepstakes is open to all attendees of the Boulder Valley Credit Union 50th Anniversary Celebration, who are eighteen (18) years of age or older at the time of entry. Employees, officers, directors, and representatives of Boulder Valley Credit Union and immediate family members (spouse and parents, siblings and children and their spouses) and persons living in the same households of each of the above are ineligible.
